Subject: Third Party Inspection Agencies (TPIAs) for certification of Emergency Response and Disaster Management Plan (ERDMP) documents for midstream and downstream activities of Oil & Gas Sector

Sir,

Based on the recommendation of Quality Council of India (QCI) vide letter dated 25.08.2014, it has been decided that M/s Certification Engineers International Ltd. (CEIL) shall continue as approved Third Party Inspection Agency (TPIA) for certifying the Emergency Response and Disaster Management Plan (ERDMP) documents under the Petroleum and Natural Gas Regulatory Board (Codes of Practices for Emergency Response and Disaster Management Plan) Regulations, 2010 w.e.f. 20.06.2014 valid upto 19.06.2018 subject to the following general terms and conditions:

1. The TPIA shall submit to PNGRB every year details of work orders awarded/executed during previous financial year no later than May 1 of the following financial year.
2. The TPIA shall provide to PNGRB every year the details of changes in relevant manpower during previous financial year no later than May 1 of the following financial year.
3. The TPIA shall facilitate periodic audits by M/s QCI and provide documentation to M/s QCI as per their requirement.
4. In case of suspension / cancellation / withdrawal of accreditation under ISO-17020, TPIA shall immediately inform PNGRB.
5. The TPIA shall submit ERDMP document duly certified to the entity with a copy endorsed to PNGRB.
6. The Board reserves the right to review the aforesaid empanelment at any time at its sole discretion.


Subject: Provisional extension of empanelment of M/s Certification Engineers International LTD. for certification of ERDMP

5. The TPIA shall submit ERDMP document duly certified to the entity with a copy endorsed to PNGRB.
