PNGRB launched 9<sup>th</sup> CGD Bidding Round On 12.04.2018, for development of City Gas Distribution (CGD) networks for the 86 Geographical Areas (GAs) which includes 174 districts (156 complete and 18 part), spread over 22 States and Union Territories (UTs) in India. Based upon the bids evaluations PNGRB in its 79th Board meeting held on 03.08.2018, approved issue of Letters of Intent (LoI) to the following 18 successful bidders for 48 Geographical Areas (GAs):
