The Petroleum & Natural Gas Regulatory Board (PNGRB) has invited bids for development of CGD networks in the Geographical Areas of **1. Kota (Rajasthan) 2. Sonipat (Haryana) 3. Mathura (Uttar Pradesh) 4. Kakinada (Andhra Pradesh) 5. Meerut (Uttar Pradesh) 6. Dewas (Madhya Pradesh).**

Following clauses in the above mentioned Application-Cum-Bid document are amended as given below:

1. Clause no. 1.4.4 of Bid document:

Bidder shall furnish a bid bond by Demand Draft ,Pay Order **or Bank Guarantee (as per Annexure 12)** of value as mentioned in 'Invitation for Application-cum-Bid', favouring Petroleum and Natural Gas Regulatory Board and payable at New Delhi issued by Nationalised / Scheduled Indian banks (except Cooperative & Gramin Bank) or any branch of Foreign Bank in India. The Application-cum-Bid without bid bond shall be summarily rejected. The PNGRB shall not be liable to pay any interest on the amount of bid bond.

2. Clause no. 3.1.1 of Bid document :

Details pertaining to number of copies of Application-Cum-Bid-Document to be submitted along with the soft copy shall be as per the sub-regulation number 4 & 5 (page no 3) of the amended regulation No. G.S.R. 800(E) dated 19/11/2008 namely, Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Network) Amendment Regulations, 2008 which reads" *the entity is required to submit in duplicate its application-cum-bid document with all enclosures .A soft copy of the application-cum-bid document with all enclosures in a compact disc with digital signatures shall also be submitted.*" Other stipulation of the Clause no. 3.1.1 remains unaltered.

3. Bid submission date & time:

- a. Bid submission date & time shall be 3rd March 2009 at 11.00 am.
 - b. Technical bid opening date & time shall be 3rd March 2009 at 3.00 pm.
- Accordingly, the date 2nd March 2009 as mentioned in Application-Cum-Bid Document, shall be read as 3rd March 2009.
