
Sub: Amendment of Authorization of Ennore-Nellore Natural Gas Pipeline in favour of M/s Gas Transmission India Pvt. Limited.

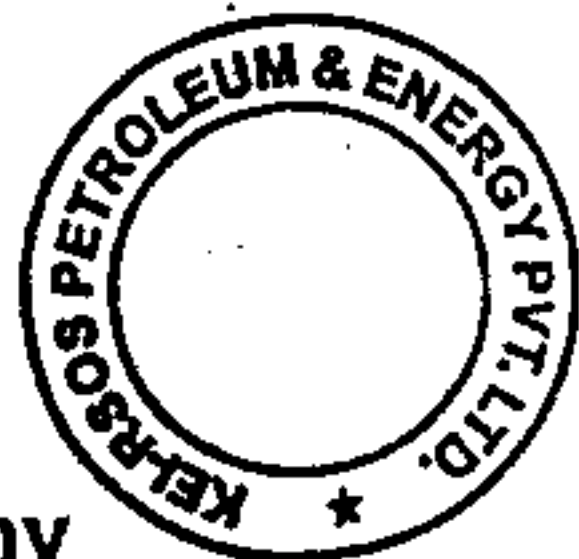
