Subject: Final acceptance for two dedicated natural gas pipelines from ONGC's Hazira Plant to KRIBHCO's fertilizer plant at Hazira (Gujarat) under Regulation 19(1) of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Natural Gas Pipelines) Regulations, 2008.

Sir,

Reference is made to your application dated 23.10.2008 for consideration of the Board for dedicated natural gas pipeline from two dedicated natural gas pipelines from ONGC's Hazira Plant to KRIBHCO's fertilizer plant at Hazira (Gujarat) and subsequent communications in this regard.

2. Considering your submissions, the Petroleum and Natural Gas Regulatory Board finally accepts the information submitted by you under Regulation 19(1) of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Natural Gas Pipelines) Regulations, 2008 and accept the two natural gas pipelines from ONGC's Hazira Plant to KRIBHCO's fertilizer plant at Hazira (Gujarat) as dedicated pipelines. Further on the basis of the submissions made, the following terms and conditions have been finalised by the Petroleum and Natural Gas Regulatory Board which shall be applicable during the operative phase of the said pipeline:

3. **Two dedicated natural gas pipelines from ONGC's Hazira Plant to KRIBHCO's fertilizer plant at Hazira (Gujarat):** The system capacities of approx. 5.0 km length, 14" diameter Low Pressure dedicated pipeline and 5.0 km

length, 16" diameter High Pressure dedicated pipeline from ONGC's Hazira Plant to KRIBHCO's fertilizer plant at Hazira (Gujarat) are 1.0 MMSCMD* and 2.0 MMSCMD* respectively as indicated by Oil & Natural Gas Corporation Ltd.

Note: [*- This capacity is accepted as provisional and the final capacity shall be determined as per the Petroleum and Natural Gas Regulatory Board (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulations, 2010].

4. This acceptance letter being issued to Oil & Natural Gas Corporation Ltd. is not transferable. In case of any proposal for change of ownership of the dedicated pipelines, Oil & Natural Gas Corporation Ltd. shall inform the same to the Board with supporting documents and convey its no objection for amending the acceptance letter in favour of the new owner/entity. The new owner/entity of the dedicated pipelines shall apply to the Board for amendment in the acceptance letter to change the name of the entity.

5. The entity shall comply with the relevant provisions under-

- a. the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Natural Gas Pipelines) Regulations, 2008;
- b. the Petroleum and Natural Gas Regulatory Board (Technical Standards and Specifications including Safety Standards for Natural Gas Pipelines), Regulations, 2009;
- c. the Petroleum and Natural Gas Regulatory Board (Protection of Consumer Interest in respect of Dedicated Pipelines for Natural Gas) Guidelines, 2010;
- d. the Petroleum and Natural Gas Regulatory Board (Affiliate Code of Conduct for Entities Engaged in Marketing of Natural Gas and Laying, Building, Operating or Expanding Natural Gas Pipeline) Regulations, 2008;
- e. the Petroleum and Natural Gas Regulatory Board (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulations, 2010;
- f. the PNGRB Act, 2006 and any other Regulations notified or guidelines issued by the Board from time to time, as may be applicable.

6. The entity shall comply with any other relevant term or condition which may be notified by the Board in public interest, from time to time.

7. You are requested to confirm your acceptance in the space provided below and return the same in original.
