Dear Madam,

This has reference to Public Notice dated 29.09.2020 (attached), issued from your office towards Unified Tariff determination. We would like to bring the following facts and concerns at our end, to your kind notice regarding proposed Unified Tariff.

- We are in Footwear manufacturing, which is primarily labour intensive and gives employment potential to large no. of workmen.
- Being producer of low priced products, margins are also comparatively very thin. Implementation of new variable tariff will lead to increase in cost putting question mark on viability of operations at our end.
- Any question mark on viability of operations will definitely lead to question mark on employment of thousands of workmen and impact on their livelihood.
- At this juncture, we are already struggling hard to remain afloat due to Covid Pandemic and with this new additional, most unexpected, tariff change, our un-certainty will further increase.

In view of the above, request you to kindly hold / cancel this revised tariff change mechanism, in the interest of industries like us.

**Public Notice**

Vide Public Notice of even number dated 29<sup>th</sup> June, 2020, suggestions/ comments/ views of stakeholders were invited on the proposed amendment to the Petroleum and Natural Gas Regulatory Board (Determination of Natural Gas Pipeline Tariff) Regulations, 2008 (“NGPL Tariff Regulations”) by 26<sup>th</sup> July, 2020. More than 30 stakeholders submitted their suggestions/ comments/ views on the aforesaid amendment. Further, as scheduled an open house meeting was held on 31<sup>st</sup> July, 2020 through video conferencing, wherein the stakeholders actively participated and presented their views. The aforesaid Public Notice, proposed amendment, suggestions/ comments/ views of stakeholders and the minutes of the open house meeting are already available on PNRB’s website.

After considering the suggestions/ comments/ views of stakeholders, the draft amendments have been reviewed proposing unified tariff for national gas grid system (integrated network of all such natural gas pipelines within India).

Accordingly, it is now proposed to amend the Petroleum and Natural Gas Regulatory Board (Determination of Natural Gas Pipeline Tariff) Regulations, 2008 (“NGPL Tariff Regulations”) as per **Annexure-1**.

An Excel spread sheet file is also enclosed (**Annexure – 2**) showing the ‘order of magnitude’ working of the Unified Tariff based on the available data for the financial year 2019-20 as a general guidance to the stakeholders.

Suggestions/ views of the stakeholders are sought on how much zone 1 unified tariff should be as a percentage of zone 2 unified tariff.

All stakeholders are requested to submit their suggestions/ comments/ views on the proposed revised draft amendment as per **Annexure-1**, to the Secretary, PNGRB by 20<sup>th</sup> October, 2020 through an email at [secretary@pngrb.gov.in](mailto:secretary@pngrb.gov.in) and/or through post at the above-mentioned address. For discussing the suggestions/comments/views, an open house meeting shall be conducted on 23<sup>rd</sup> October, 2020 at 11:00 hrs. through video conferencing.
