Subject: Declaration of Capacity of GAILs' CJHPL Network

Sir,

The Petroleum and Natural Gas Regulatory Board has promulgated the PNGRB (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulation, 2010 which were aimed to determine the capacity of NGPL & PPPL. The Board decided to assign the job of Capacity Assessment of GAILs' Chhainsa-Jhajjar-Hissar Natural Gas Pipeline from FY 2010-11 to FY 2022-23 to Engineers India Limited (EIL).

2. Data/information was sought from GAIL vide letter dated 05.08.2022, in response GAIL submitted first-hand information vide mail dated 26.08.2022 and subsequently, further details were submitted by GAIL as sought from them. Also, round of discussions were held through joint meetings to discuss the data/information and methodology for capacity assessment.

3. Further, the Board during Open House held on 03.01.2024 to discuss the Public Consultation Document (PCD) on PNGRB (Determination of NGPL Tariff) Second Amendment Regulation 2023, has informed the entities that the exercise of Capacity determination/assessment is being undertaken by EIL and PNGRB will soon declare capacity in line with PNGRB (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulation, 2010

4. EIL has assessed the capacity of GAILs' Chhainsa-Jhajjar-Hissar Natural Gas Pipeline as per data submitted by GAIL and in line with methodology as per Regulation 5(5) (a) (i to x) of PNGRB (Determining Capacity of Petroleum, Petroleum Products and Natural Gas Pipeline) Regulation, 2010. The EIL report includes details of methodology submitted/adopted by GSPL vis-a-vis EIL observations in line with Regulation 5(5) (a) (i to x) of Capacity Regulations, 2010. The EIL's capacity

assessment report dated 21.03.2024 was shared with GAIL to obtain its comments/inputs. Comments/inputs received from GAIL were reviewed by EIL and its response to same, has been made part of the Final Report. The Final Report on capacity assessment of GAILs' Chhainsa-Jhajjar-Hissar Natural Gas Pipeline submitted by EIL, has been deliberated and accepted by the Board. The year wise assessed capacity for GAILs' Chhainsa-Jhajjar-Hissar Natural Gas Pipeline from 2010-11 to 2022-23, as declared by Board is as under:
