At the outset Gujarat Gas Limited ("GGL") would like to appreciate PNGRB towards energetically striving for the development of robust Natural Gas infrastructure across country.

GGL would like to submit its comments/view on the proposed draft amendment of Petroleum and Natural Gas Regulatory Board (Determination of Natural Gas Pipeline Tariff) Amendment Regulations, 2019 for the kind consideration of Honourable Board.

With regards to amendment of clause (h) of sub-regulation (1) of regulation 2, GGL would like to appreciate Honourable Board for this positive effort in ensuring the reasonable recovery of cost to entity.

Also, with regards to amendment of sub- clause (4) of clause 9 of Schedule A, GGL would like to state that this will make tariff chargeable from prospective basis and is good step for development of Natural Gas industry. However, GGL request Honourable Board that applicability of same shall be made from first day of the month (T+2) following two months (T) instead immediatly next month (T+1). For example, if any order for zonal/levelized is issued on 29th May same shall only be applicable from 1st July in that year. This will ensure an entity having adequate time to accommodate the administrative work with regards to change in tariff.

We would be happy to provide any further clarifications should they be required by the Honourable Board in this regards.
