PUBLIC NOTICE

Petronet MHB Limited (PMHBL), vide letter no. PMHBL/EOI/17-18/01 dated 28.03.2018 had submitted an Expression of Interest (EOI) to lay, build, operate or expand Petroleum and Petroleum Products Pipeline from Hassan to Chitradurga in Karnataka state under Regulation 4(1) of PNGRB PPPL Authorization Regulations.

In this regard, an open house discussion was held on 28.08.2018 and based on the views and comments received from various entities during the public consultation process and further internal deliberations, the Board decided to invite bids to lay, build, operate or expand Petroleum and Petroleum Products Pipeline on a modified route from Devangonthi to Chitradurga in place of Hassan to Chitradurga. Accordingly, Application cum Bid was invited by PNGRB vide Bid No. BID/PPL/06/2019/02/DCPL, dated 06.06.2019.

PMHBL, filed an appeal before the Hon'ble APTEL under Section 33 of the PNGRB Act, 2006 against the above decision of the Board. The Hon'ble APTEL, vide its judgement dated 01.12.2021 set aside the ongoing Bidding process and remit the matter to PNGRB for fresh consideration.

In view of the above, the Board has decided to re-initiate the Public Consultation process for the proposed pipeline on both the routes i.e. (i) EOI application of PMHBL for Hassan to Chitradurga and (ii) the route as earlier decided by the Board and invited bids i.e. Devengonthi to Chitradurga.

In this regard, PNGRB invites views/comments from all the stakeholders, if any, within 30 days of publishing of this Public Notice through email at secretary@pngrb.gov.in with subject "EOI of Petronet MHB Limited for Hassan Chitradurga Petroleum and Petroleum Product Pipeline" or in writing through post at above mentioned address.
