**Public Notice**

The Petroleum and Natural Gas Regulatory Board (PNGRB) has received information from Indian Oil Corporation Limited (IOCL) regarding laying of 106 km long Natural Gas Pipeline originating from Petronet LNG Limited Terminal at Dahej to Koyali Refinery, Vadodara in Gujarat.

The details of the information submitted by IOCL are available on the PNGRB's website [www.pngrb.gov.in](http://www.pngrb.gov.in). In terms of the provisions of Regulation 19(2) of the PNGRB (Authorizing Entities to Lay, Build, Operate or Expand Natural Gas Pipelines) Regulations, 2008, PNGRB seeks public comments with a view to ascertain whether, instead of a dedicated pipeline, public interest would be better served if natural gas pipeline is laid, built, operated or expanded.

**Sub: Laying of Natural Gas Pipeline for Captive Purpose**

Respected Madam,

Board of Indian Oil Corporation Limited has accorded First-stage approval for capacity augmentation of Koyali Refinery to 18 MMTPA. Natural Gas demand of Koyali refinery would also increase on account of capacity expansion for usage in captive power plant and various processing units.

To meet the captive natural gas requirement of Koyali refinery, IOCL Board has recently accorded investment approval for laying of Dahej - Koyali Refinery Captive Natural Gas Pipeline. The pipeline would originate from PLL, Dahej LNG terminal and would be laid mostly in the existing available Right of Way (RoW) of IOCL enroute. Salient details of the pipeline are as under:


Length:	106 km

Delivery locations	Koyali Refinery

98 km length of this pipeline would be laid in existing RoW of IOCL and balance about 8 km stretch between PLL Dahej and IOCL's RoW would be laid in GIDC corridor.
