## PUBLIC NOTICE

In terms of provisions under Section 20 of the Petroleum and Natural Gas Regulatory Board Act, 2006 read with clause (f) of sub-regulation (2) of the regulation 19 of NGPL Authorization Regulations, 2008 and sub regulations (1) & (2) of regulation 10 of the PNGRB (Guiding Principles for Declaring or Authorizing Natural Gas Pipeline as Common Carrier or Contract Carrier) Regulations, 2009, PNGRB is of the opinion that it is necessary to declare Duliajan - Numaligarh dedicated pipeline which is owned and operated by Duliajan Numaligarh Pipeline Limited (DNPL) as a common carrier or contract carrier natural gas pipeline.

In terms of Section 20(1) of the PNGRB Act, 2006 and the aforesaid regulations, the Board invites objections and suggestions from all persons likely to be affected by such decision. Based on these objections and suggestions during the public consultation process and after hearing the entity owning the pipeline u/s 20 (2) of the Act, the Board may declare a dedicated pipeline as a common carrier or contract carrier.

In this regard, the objections and suggestions received will be webhosted at PNGRB's website for information to the public and getting comments from DNPL. Thereafter, comments of DNPL received if any, on the above will also be webhosted. Further, an open house discussion with the person or entity who had submitted their objections and suggestions will be held on 04.01.2021 at 11.00 hrs. through video conferencing.
