Subsequent to floating Tender No. PNGRB/M(C)/ GTH/ 2018/ 01/ **Revised** dated 13 April 2018, we have received queries through email, the following addendum to Tender is issued :

Clause	Existing Clause	Clarification
Page 22 QCBS Table 4	Copy of registration is an internal document and at times cannot be disclosed outside specific geography. Hence request you to allow submission of list of countries with office address, duly attested and confirmed by the authorized signatory. We may also submit the screenshots from the websites with office address as proofs. Similarly for completion certificate of international credentials, in many countries there is no concept of completion certificate and hence request you to allow submission of detailed credential with scope of work and country details, duly signed and attested by the authorized signatory.	Self certification for having offices in at least 03 (Three) countries and copy of completion certificate issued by the clients or self declaration / certification issued by Authorized Signatory of the bidder in this regard shall be acceptable.
Clause 8	We understand that, now, the bidder can provide a self declaration towards the work undertaken and being submitted towards the BEC criteria (as per sl. No. 6 & 7). However it is not evident if the same provision has been extended towards the QCBS criteria. You would appreciate the fact that due to confidentiality provisions under the service agreements, it will be extremely difficult to share the copy of our contracts. Hence, we request you to kindly permit the aforementioned modus-operandi towards substantiating our experience by way of self- declaration for the projects submitted under the QCBS criteria as well. We assure you that any such declaration shall be correct in all respects and strictly in conformity with the actual work undertaken.	Self-declaration / certification by Authorized Signatory of the bidder shall also be acceptable
Clause 7	The current tender provisions allow Bidder to use the credentials of their Parent / Holding / Subsidiary / Affiliate Company(ies) to meet the BEC.	If the bidder is getting qualified on its own credentials then only bidder's credentials shall

	<p>However, the current document does not mention about using credentials of Group Entities for evaluation under QCBS criteria. We believe that if any bidder requires credentials of Group entity to qualify the BEC, they will also require credentials of Group Entities to showcase its experience under QCBS criteria.</p> <p>Therefore, provision of submitting credentials of group entities for QCBS may also be considered in the tender. The Group entities are anyway required to provide joint and several responsibility</p>	<p>be considered. However, if the bidder is qualified based on the credentials of Group Entities, then credentials of Group Entities shall only be considered for QCBS criteria.</p>
Page 2	We request to kindly extend the date of submission of bid by one week	Extended up to 25 April 2018 at 11:00 AM
Clause 11c	We request to kindly indicate the presentation date well in advance (at least 7-10 days of prior notice) so that we get adequate time to plan the travel for the team who will be making the presentation	Presentation shall be held on 27 April 2018. Timelines for presentation shall be allotted separately
Clause 26	Request you to kindly provide the Draft contract.	Draft Contract shall be provided in due course
