Subject: Extension of economic life of Agaratala Regional Natural Gas Pipeline Network

Sir,

This has reference to your letter dated 17.08.2022, requesting PNGRB to grant the extension of economic life of Agaratala Regional Natural Gas Pipeline Network for a block of 10 years. After examining the submission made with respect to said request, PNGRB has decided to extend the economic life of Agaratala Regional Natural Gas Pipeline Network pipeline for a block of 10 years i.e. upto December 2032.

2. Accordingly, Clause 5 of final Terms and Conditions issued to GAIL vide PNGRB's letter No. Infra/PL/Exis/17/AGAR-REG/GAIL/01/10 dated 13.12.2010 & Infra/PL/Exis/17/ AGAR-REG-AMEND/GAIL/01/10 dated 13.02.2012 has been revised as below:

“As indicated by GAIL, Agaratala regional network was commissioned in year 1997-1998, the economic life of which is ending in year 2022 is further extended for another 10 years upto December, 2032 as per the proviso of 2(1)(e) of NGPL Authorization Regulations subject to submissions/confirmation provided by GAIL in compliance to Regulation 14 of NGPL Authorization Regulations, provided that GAIL must ensure the safety and integrity of the Agaratala Regional Natural Gas pipeline network all times and comply all relevant regulations of PNGRB in future also.”

3. All other Terms and Conditions shall be remained same as per PNGRB's letter No. Infra/PL/Exis/17/AGAR-REG/GAIL/01/10 dated 13.12.2010 and subsequent amendment issued in this regard.
