PNGRB invites fresh applications for engagement of Individual Engineering Consultants on contract basis. The details of level of the Individual Engineering Consultant, qualifications and experience required are as under:

Category of Individual Consultant	Qualification	Experience
Engineering: Level-I	Science/Economics/Operations Research or Equivalent from a Recognized 'University or Institution	Experience up to 5 years in: (a) Techno-economic project appraisal/evaluation/choice of project involving large investment in the field of oil and gas pipelines storages capacities, marketing infrastructure/city gas distribution etc; or (b) Development/ formulation of regulations or familiarity with latest technological development in the oil and gas sector; or (c) Setting up of city gas distribution networks, its operation and maintenance; or (d) Operation and maintenance of oil and gas pipelines; or (e) Drafting of technical standards/safety codes pertaining to oil and gas pipelines and installation. Desirable: Previous exposure to Competition Law

- 2. Terms and conditions of engagement of the Individual Consultants:
- **a.** <u>Designation & Period of engagement</u>: The Individual Consultants engaged in PNGRB will be designated as Assistant Consultant. While their term of engagement will be initially for one year extendable by another two years, one year at a time, at the discretion of PNGRB, they will be on probation for a period of six months. Based

- on their performance during the probation period, the engagement of the individual consultant may be confirmed by the Board for the balance period.
- **b.** <u>Lump sum monthly remuneration:</u> For Individual Consultants under Level I, Rs. 65,000/- with 10 percent increase on completion of each year in PNGRB. No other allowance on account of conveyance, telephone, etc will be paid.
- **c.** The age of the applicant: The age of the applicant to be engaged as an Individual Consultant as on the date of webhosting of Public Notice for the position shall be below 62 years.
- **d.** <u>Termination of Consultancy</u>: PNGRB reserves the right to terminate or curtail the consultancy period at any time without assigning any reason. In case the Individual Consultant desires to leave the consultancy services, he/she may do so by giving one month' notice.
- **e.** <u>Discharge of Functions and Working Conditions</u>: The Individual Consultants shall discharge such responsibilities diligently as may be assigned from time to time and shall abide by all day to day working conditions/facilities like closed holidays, working hours, etc. of PNGRB.
- **f.** <u>Confidentiality</u>: The Individual Consultant shall maintain confidentiality of the information/data, etc. In case it is found to be violating the code of conduct, which is generally applicable for working in a government office/establishment, by or on behalf of any Individual Consultant, apart from terminating the consultancy period, PNGRB reserves the right to take any other action as it may deem fit including legal remedies available to it such as civil/criminal case etc and may further debar such Individual Consultant from future engagement by the Board.
- **g.** <u>Leaves</u>: The Individual Consultants will be allowed to avail one day leave per month during the consultancy period. They may accumulate these leaves up to a maximum of three days and avail the same together. Beyond the above allowable leaves, the monthly consultancy fee will be reduced proportionately.
- **h.** <u>No Permanent Employment</u>: The selected Individual Consultants will be engaged on contract basis only and they will not have any right or claim for permanent employment with PNGRB. PNGRB will not entertain any type of correspondence in this regard.
- **i.** <u>Acceptance of the Terms & Conditions</u>: The selected Individual Consultants will be required to sign a copy of the engagement letter and the terms & conditions, which will be treated as a contract, at the time of joining PNGRB.
