GAIL's views : APGDC EOI to develop a Natural Gas Pipeline from Srikakulam to Angul

1. It is seen that the current EOI for developing a Natural Gas Pipeline from Srikakulam (A.P.) to Angul (Odisha) would enable the eastern part of India (*through the upcoming JHBDPL project*) to get directly connected with the Southern gas pipeline network in Andhra Pradesh (*through the upcoming Kakinada – Srikakulam natural gas pipeline and GAIL's existing KG-Basin natural gas pipeline network*). Hence the proposed pipeline can provide flexibility to the connected customers with multiple sources of gas. In view of the above, the proposed pipeline may be developed with provisions for bi-directional flows.
  
2. Furthermore, for the purpose of tariff zones for this proposed pipeline, in keeping with the Amended PNGRB Natural Gas Pipeline Authorization Regulations, 2008 dated 19.11.2008 (Ref. Explanation to Sub-Regulation 2(1)(h)- “Tariff Zone”), the point of origin and the end point in the proposed pipeline as also the sequential numbering of the tariff zones may please be indicated by PNGRB, upfront, to avoid any conceptual ambiguity with respect to originating point, terminating point vis-à-vis Entry Points and Exit Points.
